

Following rules and guidelines for shipments of used vehicles must be adhered to in addition to ACL's general terms and conditions:

1. Vehicle Description/Declaration

All vehicles must be properly declared by make/model. Motorhomes/Camper Vans/Mobile Homes/RV's ("Vehicles") or other type of vehicle with an accommodation area must be clearly declared as such at time quote/booking. Vehicles which are not declared as such but are identified as such upon receipt on terminal will be re-rated.

2. Personal Effects

No personal effects are allowed in the vehicle or in the trunk. Please note this is a security requirement because of tightened security measures imposed by various Customs Authorities around the Globe and to comply with the Ocean Carriers HSE rules and regulations.

Vehicles with personal effects will not be accepted for shipment and ACL cannot be held liable for any such personal effects being stolen at port or elsewhere.

Permitted and non-permitted items inside Motorhomes/Camper Vans/Mobile Homes/RV's or other type of vehicle with an accommodation area are as per rule 7 and 8.

ACL reserves the right to inspect all units before shipment and reject vehicles for shipments in case of non-compliance.

3. Security

Vehicles should not contain items that could be construed as being dangerous or a security liability on load or discharge terminal or during ocean transportation.

- All compartments, accommodation areas, drawers, etc must **not** be locked at any time and must be accessible at all times.

ACL reserves the right to inspect all units before shipment and reject vehicles for shipment/loading in case of non-compliance.

4. Gas Tanks/Bottles

Removeable propane/gas tanks/bottles containing propane or other gases are not accepted at any time.

Fixed/build-in gas tanks/bottles must be empty and certified as free of gas with no residues.

A gas free/cleaning certificate from a licensed company confirming that the gas bottle/tank is empty, clean, gas free and non-hazardous must accompany the vehicle and must not be older than 5 working days.

Vehicles that need electrical power (plug in) during the ocean voyage cannot be accepted.

Any motorcycles/scooters inside vehicles will only be accepted when the structure of the vehicle provides dedicated storage area for such units.

Batteries must be disconnected and contacts properly isolated as per operating manual.

In any case of any doubt or question, please contact the local ACL office or agent for further advice.

5. No Residue Policy

All rollable cargoes destined to the USA and Canada are to be presented completely clean from any soil and dirt residue to comply with USDA/CFIA regulations/requirements:

"NO DIRT OR RESIDUE ALLOWED"

Should the cargo be inspected by the USDA or CFIA and found to have residue, all related charges are for the account of the shipper and/or consignee.

Same ruling applies on all permitted standard equipment as per rule 8. > No residue, no dirt or debris

6. EV/PHEV/MHEV (AFV)

ACL does not accept any used EV/PHEV/MHEV for shipment.

7. Prohibited Items

The following items are not permitted inside vehicles at any time:

- Personal effects such as suitcases, NOS
- TV's, VCR's, DVDs except factory installed, or accessories such as CB radios.
- Electronical items such as laptops, notebooks, tablets, drones, NOS
- Flammable, corrosive or any hazardous substances, pyrotechnics, oils, paints, solvents.
- Pressurized cans, bottles or containers of any kind.
- Medical supplies or equipment, drugs
- Firearms or ammunition of any kind (even deactivated weapons or spent shells).
- Perishable goods or food stuffs, alcohol plants, or vegetation.
- Any kind of hazardous cargo (i.e. spray cans, bottles with compressed air, etc)
- Canned/bottled oil, lubricants and fuels
- E-Bikes
- Removeable Auxiliary/starter batteries and power banks

8. Permitted items inside vehicles

The permitted items must only be items that are considered as a standard item for the purpose of the Motorhome/Camper Van/Mobile Home/RV or other type of vehicle with an accommodation area. (i.e. certain kitchen utilities, bedding equipment, etc.)

The following items are permitted inside vehicles:

Camping equipment

- camping chairs, -table, tent
- portable grill or cooker (no gas tanks/bottles of any kind as per rule 4.)
- flashlight/camping lights
- canisters (empty, free of residue as per rule 5.)
- cable reel, extension cable
- portable camping toilet (empty, free of residue as per rule 5.)
- Picnic equipment (blanket, box/basket)
- Awning

Clothing

- Clothing, shoes for personal use if stored in fixed compartments/lockers and shall not be visible at any time

Kitchen equipment

- standard equipment to prepare food/meals dishes (e.g. pans , pots, can opener, etc)
- standard equipment to consume food/meals (cutlery sets, dishes, plates, glasses, etc)
- standard equipment to store food (Tupperware, freezer bags, etc) which are empty and free of residue as per rule 5.
- standard equipment to wash dishes and cooking items (e.g. sponges, brushed, paper towels, kitchen towels etc) and cleaning (no cleaning materials which are marked as hazardous)

Bedroom/Bathroom equipment

- bedding, bedsheets, pillows
- towels

- hygienic products (wipes, toilet paper, etc)

Repair and Salvage equipment

- standard equipment to change tires (spare tires (max 4), chocks, repair kits, jacks, tools for assembly)
- standard equipment for salvage (ropes, belts, shackles, chains, shovel, ladder)
- duct type
- tool box with standard tools (no battery tools)

Other Equipment

- standard first aid kit for vehicles as also supposedly required by local authorities
- high visibility vests
- warning/reflective triangle
- fire extinguisher (must be securely fixed in designated area as per vehicle operating manual)
- child seats
- bicycles – units must be properly fixed & secured for any movement.
- Factory built-in auxiliary batteries

9. General Notes

- ❖ all permitted items under rule 8. are only for personal use and not for re-sale/export and are subject to import rules & regulations of the destination country
- ❖ all permitted items under rule 8. must comply with rules 1-7
- ❖ all permitted items under rule 8. are carried at own risk
- ❖ all permitted items under rule 8. must be fixed/secured/stored inside designated storage areas/compartments of the vehicle and they shall **not** be visible at any time.
- ❖ the Ocean Carrier ("ACL") is not liable and responsible for any items inside the vehicle
- ❖ the Ocean Carrier is not liable for any damage or theft
- ❖ Vehicles are inspected upon delivery to POL terminal. In case of non-compliance with any of the above mentioned rules 1-8. Vehicles will not be accepted to gate-in or shipment/loading on board of vessel
- ❖ Rules apply to all shipments on ACL AB operated vessels
